According to the ISACA website, candidates must complete the following to earn their CISA certification:

1. Successful completion of the CISA examination
2. Submit an Application for CISA Certification
3. Adherence to the Code of Professional Ethics
4. Adherence to the Continuing Professional Education Program
5. Compliance with the Information Systems Auditing Standards

What is the CISA Certification?

CISA was designed to globally recognize professions in the role of IS audit control, assurance, and security. Earning CISA certification validates a professional's skills, experience, knowledge, and capabilities to determine susceptibility, perform compliance reporting, as well as institute controls within an enterprise.
